We are from Kabuyu Village, Rio Mukti Village, Panca Mukti Village and Polanto Jaya Village, Central Sulawesi and West Sulawesi Provinces in Indonesia.

We are writing to all of you directly regarding the issue of people's management areas or our land being confiscated by PT Mamuang, a subsidiary of Astra Agro Lestari.

Villagers have been in conflict for decades with PT Mamuang, a subsidiary of Astra Agro Lestari, whose oil palm plantation was built on disputed land and there has not even been a forest area released and it is not in accordance with the object of cultivation rights.

We understand that as Unilever and Nestle have said openly and seriously, that the company will resolve many complaints over allegations against Astra Agro Lestari for violating human rights and the environment or it can be said that land expansion is not in accordance with concession permits. With this understanding, we hope that your companies can exert influence in the Indonesian palm oil supply chain. To help us recover and return our management area which was confiscated by PT Mamuang, a subsidiary of Astra Agro Lestari.

We have made a short video asking all parties to go directly to the field and resolve conflicts caused by PT Mamuang or Astra Agro Lestari. Here's our message in the video, which asks for completion and is ready to wait for anyone who went down to the Field to inspect the object of PT Mamuang's Cultivation Right.
